OFFICIAL RULES

I. ELIGIBILITY AND ENTRY FEE

A. This tournament is open to everyone. Membership in Salmon Unlimited is NOT required.

B. All participants will compete in one, open division.

C. The entry fee is \$150 per boat.

D. All applications and payments must be received no later than June 21, 2024 at 7:00pm.

E. You must leave and return to Northpoint Marina

F. Entry fees are non-refundable after June 21, 2024, 7:00pm, except in the event of the cancellation of the tournament.

G. In the event a captain feels the weather conditions would be unsafe for his vessel, he may apply to the tournament committee for a refund up to the official start of tournament run time.

H. To be eligible for the Small Boat Award, the participant's boat must have a hull length of 21' or less.

I. All boats must be equipped with a VHF marine radio capable of operating on channels 16 and 68.

II. DATES AND HOURS

A. The tournament will be held on Saturday, June 22, 2024. Rain date will be Sunday, June 23, 2024.

B. The tournament schedule will be as follows:

1. Captain's Meeting – Friday, June 21, 2024 at 7:00pm.

Location: SU Pavilion, North Point Marina, Winthrop Harbor

2. Fishing Period - Saturday, June 22, 2024 from 5:30am to 12:30pm.

C. Each boat and crew must have at least one member in attendance at the Captain's Meeting.

D. The contest will be considered official if a total of three (3) hours are fished.

III. START AND FINISH

A. Boats must leave and return from Northpoint Marina

B. Check in will begin at 5:15am. Tournament Control will conduct a roll-call check-in by VHF radio (ch. 68). Order will be determined by the order of registration.

C. Run Time: Once checked in, each boat may leave immediately for their chosen fishing grounds.

D. The official start of the fishing period will be announced by Tournament Control at 5:30am on VHF channel 68.

E. Each boat must be inside the break-wall prior to the end of the fishing period at 12:30pm.

F. Each boat must check in with Tournament Control, by VHF radio on channel 68, as they enter the harbor.

G. Every boat must check in, even if they have no fish or elect to leave the contest early. Any boat unaccounted for will be reported as over-due to the U.S. Coast Guard. Any costs associated with search & rescue activities will be the responsibility of the boat which failed to check in.

IV. SCORING

A. All winners will be determined by the Tournament Committee and their decision will be final.

B. Winners will be determined on the total accumulation of points. Points will be assigned as ten (10) points per fish and one (1) point per pound.

C. The following species shall be eligible for points: COHO SALMON, CHINOOK SALMON, BROWN TROUT, STEELHEAD OR RAINBOW TROUT and LAKE TROUT.

V. PRIZES

A. The prize money pool will consist of 85% of the total entry fees collected. The remaining 15% will go to the Salmon Unlimited Conservation Trust to help improve the Lake Michigan fishery.

B. Cash prizes will be awarded to the top 10 boats based on the following percentages of the prize pool:

1 st	30%
2 nd	20%
3 rd	15%
4 th	10%
5 th	7%
6 th	5%
7 th	4%
8 th	3.5%
9 th	3%
10 th	2.5%

C. In case of ties, the prize money between the two or more places the participants would have won will be divided equally between the tied contestants.

D. A bonus prize of \$1000 will be awarded to the biggest eligible fish (by weight).

E. Bonus prizes of \$250 each will be awarded to the largest fish of each of the remaining species.

F. In the event of a tie, the Big Fish prizes will be divided equally between the tied contestants.

G. If no fish of one (or more) species is weighed, that species' bonus prize(s) will not be awarded.

H. A bonus prize of \$250 will be awarded to the highest scoring "small boat" (hull length of 21' or less).

I. The tournament committee reserves the right to measure boats to determine eligibility for this prize.

J. Participants may win more than one prize.

VI. BOAT IDENTIFICATION

- A. The Tournament Committee will furnish to each contestant a boat identification number.
- B. The boat identification number must be displayed on the Starboard side of the participant's boat at all times during the contest.

VII. GENERAL FISHING RULES

- A. All fish entered must be caught on hook and line in accordance with the DNR regulations of the state which has jurisdiction over the waters being fished.
- B. Any violation of USCG or DNR rules will result in immediate disqualification.
- C. Each boat is limited to a maximum of nine (9) rods and a three-person limit of fifteen (15) fish, per DNR rules.
- D. All fish must be caught by trolling. Jigging and casting are not permitted.
- E. Each boat may weigh a maximum of ten (10) fish, with a maximum of four (4) lake trout.
- F. Each team is responsible for choosing which of their fish are to be weighed, both for total catch and for individual big-fish bonus prizes.
- G. Fish entered for big-fish bonus prizes must be tagged with a zip-tie around the lower jaw.
- H. Fish entered for big fish bonus prizes must be part of the ten (10) fish tournament box.
- I. All coolers of fish to be weighed must be sealed with tape and contain only the fish to be weighed. All water must be drained.
- J. Fish may be released when caught. Fish to be released must be returned to the lake immediately.
- K. There are no distance limits as to where a tournament boat may fish as long as all traveling is done on the water.
- L. All fish kept must be logged on the fish log sheet.
- M. Each boat that reaches the fifteen fish limit shall immediately cease fishing, bring in all lines, and return to the harbor for the weigh-in.

VIII. WEIGH-IN

- A. When finished fishing, each boat must seal their cooler with tape and proceed immediately to the weigh-in.
- B. All boats must be in weigh-in at SU Pavilion by 1:30pm.**
- C. At the weigh-in, a crew member will disembark with the sealed cooler and log sheet. Tournament staff will be at the pier to direct contestants to the scales.
- D. A crew member must remain with the cooler until the catch has been officially weighed.
- E. Once sealed, the cooler of fish must remain sealed until opened by officials at the weigh-in station.
- F. The crew member will witness the weighing of their catch and sign the log sheet, to confirm agreement.

IX. CANCELLATIONS

- A. In the event of marginal weather conditions, the Tournament Committee will announce a "go/no-go" decision one hour before fishing is scheduled to begin.
- B. The Tournament Committee reserves the right to delay the start of fishing or to cut short the fishing period due to deteriorating weather conditions. However, once the contest has started, it is unlikely that it will be cancelled due to weather.
- C. Due to distances travelled, weather conditions may not be the same for all contestants. Each captain is responsible for monitoring local weather and taking appropriate steps to protect their vessel and crew.
- D. Boats may seek shelter from severe weather in any available harbor. However, all coolers must return to Northpoint by boat, before the end of the fishing period.
- E. All announcements will be on VHF channel 68.

X. PROTESTS

- A. All protests must be submitted in writing to the Tournament Committee before 5:00pm on the day of the tournament.
- B. Any written protest given to the Tournament Committee must be accompanied by a \$100.00 deposit, returnable if the protest is judged valid.
- C. A panel of three (3) judges appointed by the Tournament Committee will resolve all disputes.
- D. Winners and any person involved in any formal protest may be subject to polygraph testing, prior to the awarding of prizes. Such persons must be available to be tested within 2 weeks of the event.
- E. The decision of the Tournament Committee and/or its duly appointed panel of judges shall be final.

XI. RULE CHANGES

The Tournament Committee may change or modify any of these rules, as deemed necessary. Any changes will be communicated at the Captain's Meeting.

XII. LIABILITY EXCLUSION

- A. Each contestant shall accept responsibility to protect persons and property from injury or damage during the contest and Salmon Unlimited of Illinois shall not be responsible for the safety of persons or property of participants, regardless of cause.
- B. All participants further agree to hold Salmon Unlimited of Illinois, its officers/directors, members, tournament committee and volunteers harmless from any liability for damage incurred as a result of participation in the Tournament, in whatever form or manner said liabilities or damages might be incurred.
